A Year in Review

We **advocate** to protect

We provided advocacy for **432** sexual assault victims;
4,970 people seeking protective orders; and **34,613** crisis line calls.

We **shelter** to provide safety

We sheltered **591** women and children at our emergency
shelter and **35** women and children at our transitional living facility.

We **counsel** to promote healing

We counseled **1,604** adult and **376** child survivors of
domestic violence; **1,059** perpetrators of domestic violence;
and **329** victims of sexual assault.

We **educate** to change attitudes

We provided education to **10,248** adults and teens.

Success Story

In 2010, Michelle* escaped to Tulsa after the father of her three children abused her and held her captive. After finding safety at DVIS/Call Rape's shelter, she moved to Sojourner's Inn, our transitional living facility. While she lived there, she took full advantage of the support services available, including counseling and case management.

Michelle purchased her own home for her family upon graduating from Sojourner's. She also was able to pay off considerable debt during her stay. Through Sojourner's, Michelle developed more self confidence and became comfortable making her own decisions.

When she completed our program, she was able to take the apartment's furnishings and household items. That, and her newfound confidence and independence, helped Michelle begin a bright future with her children... free of violence or abuse.

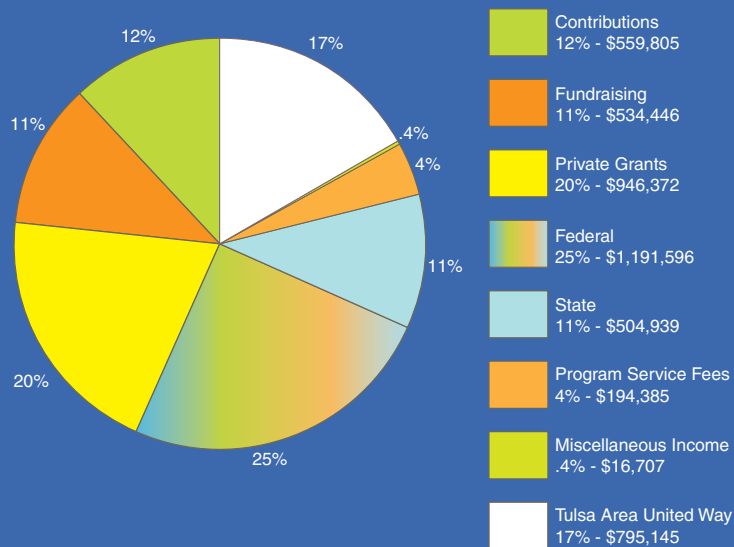

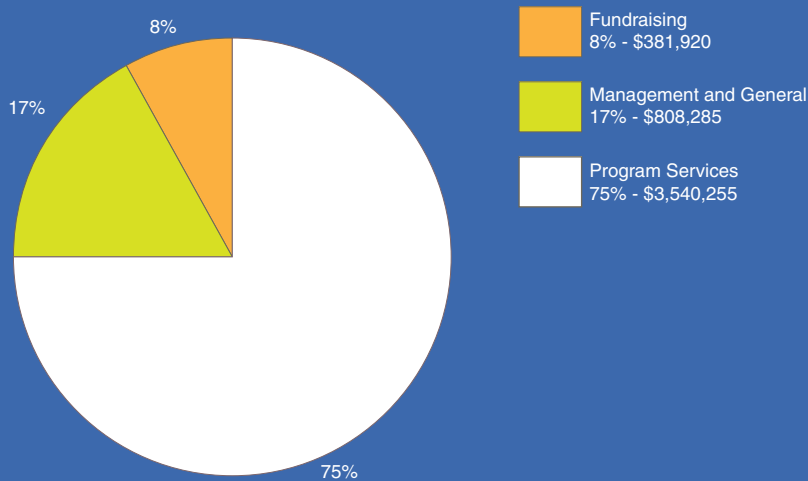
