THE TRANSITIONAL HOUSING PROGRAM FACILITATES THE TRANSITION OF SURVIVORS AND THEIR CHILDREN TO INDEPENDENT PERMANENT HOUSING. 82 WOMEN AND CHILDREN WERE SERVED AT MABEE VILLAS DURING 2018.
