THE TRANSITIONAL HOUSING PROGRAM FACILITATES THE TRANSITION OF SURVIVORS AND THEIR CHILDREN TO INDEPENDENT PERMANENT HOUSING. 75 WOMEN AND CHILDREN WERE SERVED AT MABEE VILLAS DURING 2019.
