THE 90 BED FACILITY OFFERS SAFE HOUSING, COUNSELING, REFERRALS AND CASE MANAGEMENT SERVICES. 424 WOMEN AND CHILDREN WERE SERVED DURING 21-20 AT THE SHELTER. THE TRANSITIONAL HOUSING PROGRAM FACILITATES THE TRANSITION OF SURVIVORS AND THEIR CHILDREN TO INDEPENDENT PERMANENT HOUSING. 119 WOMEN AND CHILDREN WERE SERVED AT TRANSITIONAL HOUSING DURING 2021.
